Great News! January 1, 2007, new "Well Adult Care" benefits were added to the Employee Health Plan.

Well Adult Care

Routine Well Care *(age 18 and over)

- Limited to a maximum payable of \$400.00 per year for Covered Services (see below) every 24 months under age 40.
- Limited to a maximum payable of \$400.00 per year for Covered Services (see below) every 12 months age 40 and over.

* Must have a "Routine" diagnosis to be covered under Well Care. Maximum payable of \$400.00 is **not** subject to the Deductible or the regular Co-payment percentage of the Plan.

Covered Services – Covered routine Physician and Laboratory services are limited to the following:

- Physical Exam
 - Laboratory tests and x-rays deemed appropriate by the examining physician during the course of a routine physical examination.
 - Immunization
 - Gynecological Exam (including pap smear and related lab fees)
 - Mammograms
