<p>ON FRIDAY, DECEMBER 03, 2004, I WAS DISPATCHED TO A CRASH WITH ONE VEHICLE IN A CANAL ON SR-821 SOUTHBOUND AT THE 38.9 MILE POST. UPON MY ARRIVAL, I OBSERVED MR. ARMANDO JOSE BOZA (THE DRIVER OF VEHICLE 2) AND HIS MOTHER FATIMA BOZA STANDING NEXT TO A BLUE TOYOTA. I ALSO NOTICE DETECTIVE CHONG-YEN, AND MS. FAVERON (THE DRIVER OF VEHICLE 1) ON THE GROUND NEXT TO THE CANAL WITH SEVERAL OTHER PEOPLE AROUND THEM. I ASKED DETECTIVE CHONG-YEN AND MS. FAVERON IF THEY WERE ALRIGHT AND THEY ADVISE THEY WERE. AT THIS TIME, I ASKED DISPATCH TO SEND FIRE RESCUE AND A TOW TRUCK. WHEN I SPOKE TO MS. FAVERON, SHE ANSWERED ME IN SPANISH. A GENTLEMAN AT THE SCENE, TRANSLATED FOR ME AND MS.</p>

FAVERON. MS. FAVERON STATED THAT SHE FELT TWO HITS AND SHE LOST CONTROL OF THE CAR AS IT WENT INTO THE CANAL. I THEN ASKED DETECTIVE CHONG-YEN WHAT HAD HAPPEN AND HE STATED THAT UPON HIS ARRIVAL, THE VEHICLE WAS HALF WAY SUBMERGED UNDER WATER WITH MS. FAVERON STILL IN THE VEHICLE. DETECTIVE CHONG-YEN JUMPED INTO THE CANAL TO RESCUE MS. FAVERON. ANOTHER CITIZEN (MR. ROLANDO PABLO PEREZ) ASSISTED DETECTIVE CHONG-YEN IN GETTING MS. FAVERON OUT OF THE CANAL. DETECTIVE CHONG-YEN ALSO STATED THAT THE VEHICLE HAD SUBMERGED UNDER THE WATER QUICKLY. I THEN ADVISED DETECTIVE CHONG-YEN AND MS. FAVERON AGAIN THAT RESCUE WAS ON THE WAY TO CHECK THEM OUT AND MAKE SURE EVERYTHING IS ALRIGHT. I ASKED MS. FAVERON FOR HER INFORMATION BEFORE I WENT TO TALK TO THE OTHER DRIVER (MR. BOZA) INVOLVED IN THE CRASH. MR. BOZA STATED THAT MS. FAVERON EXITED THE RAMP FROM I-75 AND TRIED TO CHANGE LANES. HE WAS DRIVING IN THE CENTER RIGHT LANE NEXT TO MS. FAVERON WHO WAS IN THE RIGHT LANE. THIS CAUSED MS. FAVERON LEFT SIDE TO COLLIDED WITH MR. BOZA'S RIGHT SIDE. MS. FAVERON THEN TRIED AGAIN TO CHANGE LANES AND COLLIDE WITH MR. BOZA'S VEHICLE FOR THE SECOND TIME. AFTER COLLISION MS. FAVERON SWERVED TO HER RIGHT CROSSING THE RIGHT PAVED SHOULDER, THE GRASS SHOULDER, AND INTO THE CANAL. AFTER THE COLLISION, MR. BOZA MOVED TO THE RIGHT PAVED SHOULDER PRIOR TO MY ARRIVAL. AFTER INVESTIGATING THE PHYSICAL EVIDENCE AT THE SCENE, I CONCLUDED WITH ISSUING MS. FAVERON A CITATION FOR IMPROPER LANE CHANGE.
